The adjourned meeting of the Council of the Corporation of the Town of Montreal South was held on the above date in the Town Hall the usual place of the meetings of this Council His Worship the Mayor J. Millie presiding Councillors present were Councillors. E. Hardy, G. Lavreau and Wm Murray.

The Secretary read over the rough minutes of the meeting held on the 4th inst.

The Mayor reported that the lawyer Mr Chauvin would get in touch with the Brennan & Carrière people and had promised to drop him a line and let him know the results so far he had not received it. and he had been able to improve on Mr Chauvin's Bill by \$61⁰⁰ the Bill now standing at \$229⁹⁰.

Councillor Hardy stated that he had examined this Bill and considered that the bill was not exorbitant when you considered that was for three years work and that he had helped us when we were down he considered the Bill reasonable.

Moved by Councillor Hardy and 2nd by Councillor Murray that this Bill be paid. Carried.

The Secretary was instructed to arrange for a meeting with Mr Desmartin and Mr Charbon in regard to the annexation By-Law for Thursday night if possible.

Carried unanimously.

Letter received from Mr A. H. Walker resigning his contract for the snow ploughing of the roads of Montreal. Moved by Councillor Hardy and seconded by Councillor Savreau that Mr Walker's resignation be accepted. Carried.

Bill for \$8⁴⁵/₁₀₀ for the cost of refreshments served at the social on the 30th of January was received. Moved by Councillor Savreau and seconded by Councillor Murray that this bill be paid, and that the committee appointed to arrange for this social be discharged with the thanks of the Council. Carried.

Councillor Murray asked if any thing was being done in regard to the Good Roads. The Mayor explained that the question should be taken up by the Road Committee as it is necessary that something should be done at once. Councillor Savreau stated that although he was not again
